

TERMS AND CONDITIONS

- ❖ You will participate in activities related to management, awareness, events, presentations, fund raising as you are a volunteer of **Wildlife Welfare Association (WWA)**.
- ❖ Your membership as a volunteer will be valid for 2 year from the date of registration.
- ❖ Work will be allotted to you by your seniors and you will have to report to them on the same.
- ❖ You must attend all the meetings conducted by the management. In case, you are not able to attend the meeting(s), you must inform your immediate supervisor. Absence in more than two continuous meetings without any prior notice will be considered as intent to discontinue. Thereby cancelling your membership with us.
- ❖ Your views, ideas and suggestions will be taken as a valuable suggestion for the betterment of NGO.
- ❖ Before applying, implementing or commencing any act, you must consult your senior(s) or respective authorities.
- ❖ If you want to address any concern about misbehaviour or issue(s), you can address your concern to your coordinator. If your coordinator does not respond to your concern, then you can address your issue directly to the core committee.
- ❖ You are not authorised to deal / touch / rescue any wild animal / bird, while you are working as a volunteer with **WWA**.
- ❖ Any misbehaviour / harm / involvement in any criminal activity related to wildlife will be considered as crime and your membership will be terminated with immediate effect.
- ❖ You will be held responsible for loss and / or damage of NGO allotted property. Penalty will be charged as applicable.
- ❖ Violation of rules, misuse of your rights, misbehaviour, spoiling of NGO's reputation or leaking NGO's protected contents to others will lead to strict legal actions from higher authorities, court of law and termination of membership.

DO'S AND DON'TS

- Do not misuse logo for your personal benefit.
- Do not use the rescue picture(s) to transmit the information to the public or social media without consulting your respective seniors.
- Avoid posting / uploading photo(s) with Indian wild animal / bird where you are holding or touching the species.
- Do not touch any dead wild animal / bird. Inform forest officials, immediately.
- Do not litter in any green zone or parks where it is difficult to maintain cleanliness.
- In case of an emergency regarding wildlife, please inform rescue team or Forest officials.
- Keep your surrounding clean, healthy and hygienic.
- Talk to others respectfully.

I hereby agree to the **Terms & Conditions** mentioned above and will hold myself responsible for any bite, scratch or wound by any animal. **WWA (Wildlife Welfare Association)** will not take responsibility for my disputes regarding any criminal / harmful activity within our jurisdiction.
